- 13) State syllabus should be followed.

- 15) All other conditions as per GOMs. No.1, Education Department, Dated 1-1-1994 should be filled.
- 16) The management is hereby informed that, the permission is being given purely on a temporary basis and is subject to the report of State Level Inspection and Vigilance Committee fulfilling of all the prerequisite conditions under A.P.Educational Act, 1982 and it later found that the school has not fulfilled any prerequisites as stipulated, the permission now being given is liable to be withdrawn at once.
- 17) The Management is hereby informed that the Fire Certificate issued by the District Fire Officer, Krishna, Vijayawada, NOC (Police Station), should be submitted at the time of submission of Recognition proposals or otherwise it will be cancelled without any notice or assigning any reasons
