I am directed to forward herewith the application received from Atkinson High School,
Vijayawada.1, Krishna District, along with enclosures in original and to state that this
Government have "No Objection" to accord affiliation to the said school, subject to
fulfillment of the following conditions:-

- i. The State Government reserves the right to withdraw the above certificate at any time without giving prior notice and without assigning any reasons if the management fails to comply with the instructions of the State Government.
- ii. Admission should be made with the bonafide date of birth certificate.
- iii. The trained teachers should replace all untrained teachers.
- iv. The management should collect all tuition fee and special fee etc. as prescribed by Government from time to time.
- v. The strength of the classes should be as per rules in force.
- vi. The management should follow the state Syllabus for classes from I to V.
- vii. The school should follow the three-language formula.

- viii. The District Educational Officer or his nominee should be invited when the management makes recruitment of candidates for various categories of posts.
- ix. Staff salaries should be paid as per Government scales of pay.
- x. Various facilities including infrastructure, play area etc. should be provided as per prescribed norms.
- xi. The management should not collect donations either from the students or parents for admission.
- xii. The management should implement the teachers' provident fund scheme.
- xiii. No pupil studying in the school now be put to hardship for continuing in the same school.
- xiv. No classes should be opened without prior sanction / permission from the competent authority.
- XV The management shall follow the traffic and guidelines indicated by the Police, Fire services and the Transport departments. The instructions issued in Cir. Memo. No.21748/D1/97, dt.16-2-1998 and other orders of transport department for safe transportation of school children should be scrupulously followed.
- xv. The management should provide fire protection arrangements as prescribed in the National Building Code of India part IV Fire Protection 1997 and its amendments from time to time.
- xvi. They should abide by the State Government rules, regulations and orders issued from time to time.
